



Assumption of risk release and waiver of liability indemnity agreement

No participation will be allowed in any hunting/shooting/fishing activities until this form is read and signed.

Lonesome Quail Ranch, (here in after to be considered as LQR) and employees, representatives, officers, volunteers, guides, and agents (here in after to be considered as LQR Staff).

I _____ hereby sign this agreement on behalf of myself, my personal representatives, heirs, assigns and next of kin.

By reading and signing this form I hereby warrant to you that:

1. I am familiar with the risk of serious injury or death which any participant in a fishing/hunting/shooting trip must assume.
2. I am physically and emotionally able to participate in this hunting/fishing/shooting trip, and that my equipment is mechanically fit for use during this hunting/fishing/shooting trip
3. I have read, signed and understand the rules sheet provided by LQR and will follow them as stated. I understand that my safety first depends on myself and my actions.
4. I will immediately remove myself from participation, if at any time I sense or observe any unusual hazard or unsafe condition or if I feel that I have experienced any deterioration of my physical or mental fitness for continued participation in the hunting/fishing/shooting trip.

I understand and agree, on behalf of myself, my heirs, assigns, personal representatives and next of kin, that my participation in this hunting/fishing trip and execution of this document constitutes the following:

1. An undertaking not to sue the LQR, LQR staff, or associates of the LQR for any loss, injury, cost of damages to my person or equipment of any form or type howsoever caused of arising, and whether directly or indirectly from my participation in the hunting/fishing/shooting trip.
2. Full and final release and waiver of liability of the LQR and LQR staff and those associated with LQR of and with respect to all injury, disability, death or loss or damage to person or property whether arising from the negligence, gross negligence, or negligent rescue of or by LQR, LQR Staff or rescue personal.
3. I agree to indemnify, save and hold harmless the LQR, LQR staff, and associates of the LQR from any litigation expense, legal fees, liability, damage, award or cost, of any form or type whatsoever, they may incur due to any claim made against them or any one of them whether the claim is based on the negligence of the gross negligence of the LQR, LQR staff or LQR associates.
4. I have read and understand the LQR rules sheet and signed and dated it accordingly to directions provided. I agree to follow all LQR rules at all times and obey all LQR staff instructions.

I have read and understand this document and of sound mental capacity to sign this document.

I understand that the releases are relying upon my warranties, assumptions waiver and release, undertakings and agreements when accepting my participation in this hunting/fishing/shooting trip.

I understand that by signing this document I forgo substantial legal rights I would otherwise have.

I sign this document voluntarily and without inducement.
